

# Agreements with Government Agencies and Professional Bodies

## Recognition of NATA's role - NATA /Commonwealth MOU

Under a Memorandum of Understanding between NATA and the Commonwealth of Australia, NATA is recognised as:

- the national authority for accreditation of laboratories and producers of reference materials;
- a peak authority for accreditation of inspection bodies and proficiency testing scheme providers; and
- Australia's compliance monitoring authority for facilities undertaking non-clinical health and environmental safety studies in accordance with OECD Principles of Good Laboratory Practice (GLP).

The MOU applies to all non-corporate Commonwealth bodies and also details a broad range of individual and joint undertakings aimed at facilitating a reliable conformity assessment infrastructure to serve the national interest and for public benefit.

## Memoranda of Understanding and Deeds relating to regulatory requirements

NATA enters into agreements with Commonwealth, State and Territory Government agencies where NATA accreditation is utilised by the agency to underpin a regulatory or policy objective. These typically involve cooperation on policy and/or industry developments, advice on matters of conformity assessment and the exchange of information on concerns with, or poor performance of, accredited facilities which may seriously compromise the relevant policy or regulatory objective.

Memoranda of Understanding will include objectives of the agreement followed by the undertakings of each party and the joint undertakings.

Deeds of Agreement are contractually binding and describe NATA's obligations to the relevant agencies.

The following table lists current agreements which may impact on facilities (including the disclosure of information otherwise considered as privileged under NATA Rule R.39). Agreements are listed per Sector, in some cases where agreements have cross Sector coverage; the Agreement is listed under each Sector.

## Memorandum of Understanding with professional bodies

NATA also maintains MOUs with the Professional Bodies with whom joint accreditation programs are operated in clinical services.
